An initial flush is recommended prior to use.

- The product complies with German Recommendations XXXVI and XXXVI/1, as well as with the German Foodstuffs and Animal Feed Code (LFGB) §§ 30 and 31. Sheet materials have been extraction tested with hot water at 85 °C (185 °F) to German recommendation XXXVI/1.
